## CONSUMER COMPETITION RULES

# **"GOLF TRAILS"**

These rules (the "Rules") contain a complete set of terms and conditions for the consumer competition called "GOLF TRAILS" (Hereinafter referred to as the "Competition"). These rules are available 24/7 for the whole duration of the competition at www.teetime.cz/stezky and constitute the only binding document in relation to consumers governing the rules of the competition. These rules may only bealtered by written amendments to this document published in the same manner as this document. Excerpts from these rules or a shortened version of these rules included in advertising and promotional materials are for informational purposes only and are not legally binding rules for this contest.

# **1. COMPETITION ORGANISER**

The organiser and promoter of the competition is TeeTime SE, with registered office at Štětkova 1638/18, Nusle, 140 00 Prague 4, ID No.: 242 36 381, registered in the Commercial Register maintained by the Municipal Court in Prague under the Commercial Register No. H 840 (hereinafter referred to as the "**organiser**" or as the "**promoter**"), the operator TeeTime SE (hereinafter referred to as "**operator**").

# 2. PLACE AND TIME OF THE COMPETITION

The competition will take place on the territory of the Czech Republic, the Slovak Republic and the European Union (hereinafter referred to as "the **site of the competition**" via the TeeTime SE reservation system (hereinafter referred to as the "competition platform") from 18 April 2024 00:00:00 to 31 August 2024 23:59:59 (hereinafterreferred to as the "competition period" or "contest period").

## **3. PARTICIPANTS IN THE COMPETITION**

Any natural person over the age of 12 years who has a valid user account with TeeTime SE on the Competition Platform under his/her name and who meets the conditions for participation in the Competition set out in these Rules (hereinafter referred to as "Competitor" or "Participant"), i.e. a person who orders and pays for a game online via the Competition Platform (TeeTime SE) at any of the golf courses listed below (see Article 4) at the time of the Competition, may participate in the Competition.

Any entrant who fails to properly comply with the conditions of entry in accordance with these rules at the time of the Competition will be excluded from the Competition. Furthermore, all persons in an employment or similar relationship with the organiser, persons personally and financially related to the organiser or persons who are close to such persons within the meaning of Article 22(1) of Act No 89/2012 Coll., Civil Code, as amended (hereinafter referred to as the 'Civil Code') are excluded from participation in the competition. In addition, all users of the competition platform who request the organiser to do so and expressly state that they are not interested in entering the competition will be excluded from the competition; this request will be made in writing and sent to the organiser's email address, i.e. golfovestezky@teetime.cz.

The Promoter reserves the right to exclude from the Competition those competitors whose competitive behaviour shows signs of fraudulent competition or who are otherwise reasonably suspected of abusing the Competition or circumventing these rules in contravention of the rules of this Competition or the purpose of the Competition. The Promoter reserves the right at any time, at

its sole discretion, to assess the compliance of individual competitors with the conditions of the Competition and to exclude competitors who do not comply with the conditions set out in these Rules from the Competition.

In the event that the winner is an excluded person, the prize will not be handed over to them and will be forfeited to the Promoter.

The competition is intended for end users - consumers, not for legal entities. Any entrant who fails to meet the above conditions will be disqualified from the competition without entitlement to the prize.

# 5. COMPETITION CONDITIONS

The classification of a participant in the competition is judged according to the following units:

- Points,
- trails.

To be eligible for the 14-day draw, an entrant must have earned at least one (1) point within the 14-day period defined for that 14-day draw.

As a condition of being entered into the monthly draw, a participant must complete at least one (1) trail in the month preceding the monthly draw date.

The condition for inclusion of the participant in the final draw is the completion of at least three (3) trails during the competition period.

The condition for a participant to qualify for the final tournament is to obtain a higher number of points than the other participants. The 48 participants with the highest number of points will qualify for the final tournament.

# **GETTING POINTS**

Points can be earned for playing and paying the online game fee, i.e. for 9 or 18 holes (hereafter referred to as "the **Game**") via the competition platform on one of the list of golf courses set out in Article 4.

Contestants will receive 2 points for completing the entire 18-hole course and 1 point for completing the entire 9-hole course, including the corresponding number of TeeCoins for each game. However, if a player successfully completes only a half, or 9 holes, of the 18-hole course, no points will be awarded. In the event that a player pays in advance and then plays 18 holes in such a way that the game is split into two rounds of 9 holes on a 9-hole course, each round will be treated as a separate game, therefore the player will receive a total of 2 points.

# TRAIL CLOSURES

Completion of the Trail means the completion and play of a set of games on each course belonging to the Trail as defined in Article 4 of these Rules. At least one game must be played on each course belonging to the trail.

A competitor may visit each course belonging to a specific trail repeatedly and is entitled to receive points for each visit, but the bonus for completing the entire trail can only be awarded once for each specific trail.

If a player pays the online fee for multiple entrants, all participating players are entitled to points towards the competition, not just the one who paid the fee, but only if they are also registered on the competition platform.

In the event that a competitor (player) plays a game at his/her home club where he/she has an active membership and therefore does not pay a fee for each game, that game will be counted towards the competition within the trail, however the competitor will not receive any points for that game.

The more points a contestant accumulates each time in a given period for each draw, the more times they will have a chance to win that draw. Each point earned means one entry into the draw. A player can only win one prize per draw.

## 6. WINNING

## **DRAW PROCESS**

Each entrant participating in the draw for this competition is entitled to win up to one prize in any one draw. In the event that a contestant is drawn more than once in a single drawing, their next prize will automatically be entered back into the drawing.

Winners will be drawn via a random number generator provided by VeroMotion.

# D. FINAL TOURNAMENT - PARTICIPATION

The condition for a participant to qualify for the final tournament is to collect the highest number of points in the competition period. The 48 participants with the highest number of points will be selected and sent an invitation to the final tournament, which will be held on 14 September 2024.

In the event that the contestants achieve the same number of points, the winner will be decided based on the number of bonus points earned. Another criterion for determining the winner is the date of the last game played, with preference given to games played earlier. In the event that this criterion also fails, the total amount of money spent by the participants on the purchase of fees in the competition will become the deciding factor.

# 7. TRANSFER OF WINNINGS

The winners of each prize will be announced within 3 days of the draw. In all cases, the winners will be announced via the teetime.cz website in the form of their first name and the first letter of their surname (e.g. Tereza V.). In the event of winning, the winner will be contacted by e-mail to the e-mail address associated with his/her user account on the competition platform and at the same time by calling and/or sending a text message to the phone number provided by the contestant in his/her user account on the competition, the Contestant in his/her user account on the competition, the Contestant acknowledges that his/her email and phone number registered in the contest platform will be used to communicate the contest winnings. The Promoter is not responsible for any incorrect email or phone number or any other errors within a competitor's user account.

In the event that the winner (contestant) cannot be contacted within 14 days of the announcement, the prize will be forfeited to the Promoter.

At the Promoter's discretion, the prize may be handed over to the winner in person, or the Promoter may meet the winner in person at a time and place to be specified by the Promoter, unless otherwise agreed between the Promoter and the winner.

In the case of a credit ("fee") prize, the prize will be uploaded to the winner's user account on the competition platform within 3 working days of the winners being announced. The credits ("fee") are valid for 12 months from the moment of uploading to the winner's user account on the contest platform.

The winner (contestant) is obliged to pay a 15% tax on prizes exceeding CZK 10,000.

Alcohol containing prizes can only be claimed by a person over the age of 18. Otherwise, a legal guardian over the age of 18 may claim the prize.

The Promoter accepts no responsibility for any risks and liabilities associated with the use of prizes. The risk of damage to the prize passes to the winner at the moment of handing over the prize to the winner. The Contestant cannot claim any prize other than the one issued to him/her and is not entitled to claim the prize. Prizes may not be paid in cash or any other form of consideration. Evaluation and announcement of the competition is made by the Promoter. The Promoter reserves the right to change the prizes as well as any changes to the rules during the course of the competition. Any legal action to claim the prizes or participation in the competition is excluded. Inthe event of any dispute or ambiguity, the competition organiser has the right to decide.

# 8. PROCESSING OF PERSONAL DATA

The organiser undertakes to process the personal data of the competitors in accordance with the relevant legislation, in particular Act No. 110/2019 Coll., on the processing of personal data, as amended.

By participating in the competition, the participant agrees to the inclusion of all personal data provided by him/her (hereinafter referred to as "data") to the database of TeeTime SE, with registered office at Štětkova 1638/18, Nusle, 140 00 Prague 4, ID No.: 242 36 381, as the personal data controller (hereinafter referred to as the "controller" or also the "processor"), which is entitled to process his/her personal data for the purpose of participation in the competition (Article 6(1)(b) of Regulation (EU) 2016/679 of the European Parliament and of the Council), whereby this purpose includes in particular the following processing operations: a) storage of personal data upon registration and/or inclusion in the competition, b) sending informative e-mails or contacting competitors via calls or SMS on matters related to the organization and management of the competition, c) processing of personal data for the purpose of control and evaluation of the competition according to the rules, d) personal, telephone, written and electronic contact to verify the compliance with the conditions of the competition by the competitor, information about the prize and other related communications. The participant also agrees to the processing of data through the processor for the company's marketing purposes, i.e. offering products and services, including sending information about organised events, products and other activities, as well as sending commercial communications by electronic means in accordance with Act No. 480/2004 Coll., on Certain Information Society Services, for a period of time until the withdrawal of consent.

The personal data will be processed automatically and securely in electronic form for the time necessary for the organisation of the competition, the control of compliance with the conditions of the competition and possible control by public authorities in accordance with legal regulations.

As a data subject, the competitor has the following rights under the law, which can be exercised at any time. These are the right (i) to access the personal data, (ii) to rectification of

inaccurate or untrue personal data and the completion of incomplete personal data, (iii) to delete personal data if the personal data are no longer necessary for the purposes for which they were collected or otherwise processed or if it is established that they were processed unlawfully, (iv) to restrict the processing of personal data, (v) the portability of the data; and (vi) the right to object, after which the processing of the competitor's personal data will be terminated unless it is demonstrated that there are compelling legitimate grounds for the processing which override the interests or rights and freedoms of the competitor, in particular if the grounds are for the enforcement of legal claims. At the same time, the competitor has the possibility to lodge a complaint with the supervisory authority, which in the Czech Republic is the Office for Personal Data Protection (www.uoou.cz).

In order to exercise their rights, file a complaint or in case of any query, the competitor may contact the Administrator by e-mail sent to: <u>golfovestezky@teetime.cz</u>.

By entering the competition, the entrant gives permission for the Promoter to distribute the name, surname and city of residence of the winner used in the competition free of charge, and in the event of a personal meeting between the Promoter and the winner or the presentation of the prize, to capture, display, reproduce and distribute the image free of charge, image, likeness, images and visual and audio recordings relating to the winner, including their processing and inclusion in an audiovisual work, on the Promoter's competition website or social media for the duration of the competition and for a period of five (5) years from the end of the competition period.

## 9. FINAL PROVISIONS

By participating in the Competition, the Contestant accepts without reservation that the Competition is organised and administered in accordance with Czech law and that any disputes relating to the Competition will be settled exclusively before the courts of the Czech Republic.

By participating in the Competition, each Contestant also confirms that he/she meets the conditions for participation in the Competition set out in these Rules.

Unless otherwise specified by the Promoter or these rules, all notifications about the competition, its progress and changes will be made via the competition website. The Promoter shall not be liable for temporary unavailability of the competition website caused by objective circumstances, in particular a defect in the internet connection or other technical failure.

The Promoter reserves the right to change, restrict, postpone, or suspend the rules of this competition or its implementation, including its validity period, or terminate the competition at any time during the competition period. This will be immediately notified to the competitors on the competition website. The Promoter shall be entitled to check that all conditions for participation in the Competition have been met and, in the event of a dispute, to make a final decision on any issue relating to the Competition.

The Promoter reserves the right to make final decisions on all matters relating to this competition. The results of the competition are final, without the possibility of appeal. The final decision on disputed issues is always up to the Promoter.
